(This does not form part of the notification, but is intended to indicate its general purport.)

Vide G.O.(Ms.) No.21/2024/Home dated 19th October, 2024, the Government have sanctioned the establishment of a Special Court of Judicial Magistrate of the First Class for the trial of cases under section 138 of Negotiable Instruments Act, 1881 (Central Act 26 of 1881) at Kollam. It is now decided to start the functioning of the said Special Court at Kollam District Centre with effect from 20th November, 2024, as a Digital Court on pilot basis as '24x7 ON Court'. Hence this notification.
