STATEMENT

The Bombay Bar Association notes the recent events relating to issuance of summons by Directorate of Enforcement ("ED") to Mr. Arvind Datar and Mr. Pratap Venugopal, two distinguished Senior Advocates. Though, such summons are now withdrawn, the very issuance of such summons, by itself strikes at the very root of protections guaranteed to Advocates by law in India. These recent events have shocked the collective conscience of members of the legal fraternity all across India.

The Bombay Bar Association strongly condemns the steps taken by the ED qua the two distinguished Advocates by issuance of summons, during the course of a money laundering investigation. The issuance of summons by the ED to the two distinguished Senior Advocates, is perceived by the members of this Bar, as a direct attack on the legal community as a whole.

Advocates accept any professional assignment on the basis that during the course of such professional work, they would not have to face intimidation, or threats of any kind. No person including any investigative agency ought to be permitted to take any action, which can have the effect of deterring any Advocate or members of the legal community as a whole from offering their services to any client. The preservation of rule of law can be achieved through strong participation from members of the legal fraternity, who are bound to feel threatened in case a summons is issued by any investigating agency to them, in connection with their professional work. The powers of the ED to investigate are statutory and the same ought to be exercised within the bounds of the entire legal framework established in India, which includes legislations viz. Adhiniyam, 2023, which specifically protects Professional Communication and Confidential Communication between Advocates and their clients.
